CITY MANAGER:

Promise Neighborhood Grant and Restore Program:

I met with representatives from the federal government regarding the Promise Neighborhood grant on March 29th and 30th. I also met with Tony Cardenas regarding details of the Restore Program and usage of operational funds on April 6th.

Expect More Tehama:

I attended an Expect More Tehama brainstorming session on March 30th to discuss what Expect More Tehama is going to achieve and work towards in the next five years. Ideas were brainstormed for the executive team to decide upon.

Joint Pharmaceutical Drug Disposal Ordinance Meeting:

I attended a joint City/County meeting on April 3rd at the Tehama County Board of Supervisors Chambers to discuss passage of an ordinance that requires manufacturers of pharmaceutical drugs and sharps to develop, fund, and manage a pharmaceutical drug take back program. Passage of such an ordinance would be one tool in the tool box to better tackle opiod abuse and addiction within our community. The next step will be formally asking each jurisdiction if they are interested in pursuing such an ordinance.

AirCon Energy Proposal:

I met with AirCon Energy to discuss energy efficiency improvements within City buildings. AirCon Energy will make a proposal to the City Council at its April 25th meeting and ask the Council to select the firm pursuant to Government Code Section4217.10-4217.18. Assuming the City Council selects AirCon Energy, the firm would then conduct an investment grade audit. Preliminary estimates indicate first year savings of approximately \$22,900.

Economic Development Action Committee Meeting:

I will attend an Economic Development Action Committee meeting on April 10th, whereby a representative from Shasta College will explain efforts to improve transportation to and from Shasta College.

Regional City Manager's Meeting:

I will be attending a regional City Manager's meeting on April 13th.

Business Walk

I visited ten businesses to better get to know them and understand their needs on April 5th.

Free Passenger Tire Collection Event:

A free passenger tire collection event will be held on Saturday, April 8, 2017 from 8 a.m. to 12 p.m. at the Los Molinos Transfer Station (Aramayo Way in Los Molinos), Manton Transfer Station (Hazen Road, Manton) and the Tehama County/Red Bluff Landfill (19995 Plymire Road, Red Bluff).

Collections include:

- Up to 9 tires per trip without exemption
- Up to 20 tires per trip with exemption
- Maximum of 40 tires per property
- Tires may be on or off the rim
- No tires larger than 17"
- No large truck tires or equipment tires
- No oil, paint, batteries, appliances, or other items
- No tires from waste tire generating businesses
- If tires were illegally dumped, call 530/528-1103 for additional information
- Electronic waste will be accepted free of charge at the <u>Los Molinos site ONLY</u> during the tire event.

PUBLIC WORKS DEPARTMENT:

PG&E LED Street Lighting Upgrade Project:

PG&E has contracted DC Electric Group, Inc. to upgrade the lighting fixtures throughout the City of Corning. The project began on March 27th and was completed on April 4, 2017.

Hazard Mitigation Update:

The Tehama County Multi-Jurisdictional Hazard Mitigation Planning Meeting was held on March 30, 2017. Tehama County along with the Cities of Corning, Red Bluff, and Tehama will develop an update to the 2012 Tehama County Hazard Mitigation Plan (HMP) to reduce further losses resulting from disasters. Hazard mitigation is the use of long and short term actions to reduce the loss of life, personal injury, and property damage that can result from a disaster. It involves planning efforts, policy changes, programs, capital projects, and other activities that can mitigate the impacts of hazards. The 2017 HMP Update will cover each of the major natural hazards that pose risks to County infrastructure and residents.

Public Works Director Dawn Grine, Fire Chief Martin Spannaus and Planning Consultant John Stoufer will participate as representatives for the City of Corning.

The next scheduled Planning Meeting is set for May 4th, 1:30 to 3:30 p.m. at the Tehama County Department of Agriculture in Red Bluff.

POLICE DEPARTMENT:

In addition to responding to 173 calls for service, a total of 43 officer reports were taken and there were 138 officer-initiated incidents, including 67 traffic stops. Officers made 17 misdemeanor arrests and 4 felony arrests. Officers issued 30 citations, of which; 16 were misdemeanors, 2 were felony, 9 were infractions, 1 was animal-related, and 2 were unclassified during the period of March 30, 2017 through April 5, 2017.
