- E-2: **Mountain View Estates Project - Foster Corning LLC; Public Hearing to receive comments regarding the Draft Environmental Impact Report;** Project encompasses approximately 77.3 acres; it is proposed to subdivide approximately 76.48 of these acres into 343 parcels for Single-Family Residential development. Located on the west side of Highway 99 W and north of Blackburn Avenue. APN's: 69-150-53, 54, 71, 72, and 40 – 44.
- E-3: **General Plan Amendment 2006-2A; Rezone 2006-4; Tentative Tract Map – Palm Avenue Subdivision;** to create 37 Single-Family Residential Parcels in an R-1 Zoning District. Located between southern end of Palm Avenue and Jewett Creek, APN: 71-300-63, approximately 10.5 acres. Continued from the May 16, 2006 meeting.
