**1. Waive the Reading and Approve the Minutes of the October 6, 2009 Recreation Commission meeting with any necessary corrections.**

Commissioner Lauderdale moved to approve the Minutes of the October 6, 2009 Recreation Commission Meeting as written. Commissioner Turner seconded the motion. **Ayes: Price, Johnson, Lauderdale, and Turner. Opposed: None. Absent: Boles. Motion was approved by a vote of 4-0.**

**2. Discussion of the Recreation Winter Activity Guide.**

Recreation Supervisor Kimberly Beck updated the Recreation Commission regarding the progress of the winter activity guide. Beck asked the Commission if they have received any feedback from the community about existing or new programs. One of the programs that the community would like to see is a consistent Hunter Safety Course. Commissioner Johnson said to contact Allen Job, Tyler Young, or Warren Duke.

**3. Discussion of Proposition 84 Park Grant Application and Recommendation of New Park Location.**

Beck briefly talked to the Commission about the grant. She then asked the Commission to select two (2) locations to recommend to City Council at their November 10<sup>th</sup> meeting. The Commission asked Planning Director, John Stoufer, what locations he recommends. Stoufer pointed out a variety of locations and discussed some of the pros and cons. Stoufer emphasized the point value of the properties. After multiple questions and discussion, the Recreation Commission took an informal vote and decided to rank the 10 acres north of Woodson Elementary as their top pick and the 10.87 acres off of Fig Lane as their second choice.

Commissioner Lauderdale moved to recommend City Council approval of either the ten (10) acres north of Woodson Elementary school or the 10.87 acres off of Fig Lane as the new park development location. Commissioner Johnson seconded the motion. **Ayes: Price, Johnson, Lauderdale, and Turner. Opposed: None. Absent: Boles. Motion was approved by a vote of 4-0.**

**4. Update on the October 19th, 2009 Corning Skate and Bike Park Committee Meeting.**

John Richards spoke on behalf of the Committee. He addressed the seven citations that were issued to skateboarders at West Street School. The Committee met with West Street School and have schedule a clean-up day on November 7<sup>th</sup>, 2009 at 8am. The school will provide the supplies

for the clean-up and the skateboarders will work on mending the damages they created. The next Skateboard Park Committee Meeting will be held on November 16<sup>th</sup> at 6pm in the City Council Chambers.
